## NOTICE TO EXHIBITORS

The **Show Site** will be available to exhibitors at 2:00 p.m. on Thursday, July 30th for set up. The building will close at 6:30pm on Thursday. On Friday and Saturday the building will open at 7:00am and close at 6:00pm. **JUMP HEIGHT ORDER:** Jump Height Order will be lowest to highest in all classes at all three trials.
