NOTICE TO EXHIBITORS

The **Show Site** will be available to exhibitors at 2:00 p.m. on Thursday, July 30th for set up. The building will close at 6:30pm on Thursday. On Friday and Saturday the building will open at 7:00am and close at 6:00pm. On Sunday, the building will open at 7:00am and dogs must be removed from the building immediately following the conclusion of judging.

ENTRIES CLOSE at 6:00p.m., Wednesday, July 15, 2015, after which time entries cannot be accepted. No entry may be altered, substituted, or cancelled unless written notice is received by the Trial Secretary prior to closing date, except for bitches in season.

All entries must be on an official AKC entry form (including the back side), completed and signed. Photocopies without the agreement and rules on the reverse side of the official AKC form are not acceptable. Please TYPE or PRINT LEGIBLY.

ENTRY FEES will not be refunded in the event that a dog is absent, disqualified, excused by a veterinarian (except for bitches in season) or barred from competition by action of the Trial Committee. No entry fees will be refunded if the Show cannot open or be completed because of extreme weather conditions, riots, civil disturbances, a public emergency, or any other cause beyond the control of the Club.

BITCHES IN SEASON: A written request from the owner, accompanied by verification of a veterinarian, must be postmarked or given to the Trial Secretary at least 30 minutes prior to the start of the trial. The entry fee, less \$5.00, will be refunded. No bitches in season may be inside the show facility.

ERRORS ON ENTRY BLANKS: Owners are responsible for errors and/or omissions on entry forms. No entry fee will be refunded in the event of such error or omission.

TRANSFERS (formerly Move-Ups) are allowed for Obedience and Rally Trials in accordance with Chap 1, Sec 16a of the Obedience Regulations. All requests must be in writing at least 30 minutes before the start of the Trial, not the start of the class.

CATALOGS: Catalogs may be pre-ordered by including \$3.00 per catalog with your entry fee and filling in the appropriate spaces on the entry form. Pre-paid catalogs will be available at the secretary's table. A very limited number of catalogs will be available at the trial.

JUMP HEIGHT ORDER: Jump Height Order will be lowest to highest in all classes at all three trials.

There will be **NO CONCESSIONS** on site. Complementary coffee will be available each morning. There are a number of fast food restaurants in the area.

All dogs must be on leash or confined to crates, except when being judged. Prong collars are prohibited on the trial site. No ex-pens will be allowed inside the trial site.

In accordance with city ordinances, **NO SMOKING** is allowed inside the building.

A Recording Fee of 50 cents for each dog and an AKC Event Service Fee of \$3.00 will be required for each recordable single entry class at any Licensed or Member Club Show or Obedience Trial. (American Kennel Club Rule, Chapter 11, Section 2). These Fees are paid to the American Kennel Club.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

The show giving Club, the Show Secretary, their agents, employees, etc, assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assume no responsibility for injury to children.

The Club reserves the right to substitute a prize of equal or greater value. All trophies must be claimed the day of the show - None will be mailed.
