**DIRECTIONS:** Go South on I-65 to I-865 East (exit 129) to I-465 East. Then take exit 27 (421 N/Michigan Rd.) and turn right at the exit ramp. Go 0.8 mi. and turn right on W. 86th St. Stay in right lane and go 0.4 mi. to the hospital. This is a 24 hour facility and animals do not have to be removed from the clinic if it is necessary for an overnight stay. Total distance about 17 miles.

## ROUTES TO THE SHOW

**COMING FROM SOUTH ON I-65:** Take Exit 138 (first Lebanon exit). At the end of exit ramp, turn right on County Road 100S. Fairgrounds visible on your left.

**COMING FROM NORTH ON I-65:** Take exit 138. At the end of the exit ramp turn left onto CR 100 E and go over the interstate. Continue 0.3 mi. on CR 100 E to stop sign at Indianapolis Ave. Turn right and go 0.1 mi. Boone County Highway Department building will be on left side and the North entrance to Fairgrounds is just past that building. If you miss this entrance, continue to CR 100 S where you must turn left as you can't enter the exit ramp for northbound I-65. Fairgrounds visible on your left.

**COMING FROM EAST ON HWY 32:** As you come into Lebanon, turn left on Indianapolis Ave. Go about ½ mile. Fairgrounds N entrance visible on your left, or go to County Road 100S and turn left.
